- 2) Review and Approve Minutes for 08/19/12
 - MSP 4-0 Minutes Approved
- 3) ACC update (from email)
 - Rich to visit specific home owner to check on compliancy progress
 - Update on progress being made by a specific home owner with compliancy issue
 - Discussed projects for this year
 - i) Stopping landscape maintenance for fall / winter to help pay for low maintenance landscape changes

- One delinquent homeowner is now paid in full
- One specific homeowner explained their situation and plan to resolve
- No response so far from two other delinquent homeowners
 - i) Discussed if payments paid are consistent with current agreements
- Discussed rest of expenses on track
 - i) Almost all costs recouped from pumps and waterfall improvements
 - ii) Budget is fine but a bit low as we move into year end
- Estimate 2013 assessment will be about the same as 2012
- Discussed if we can show ROI of projects so far
- Discussed landscaping and Anne Marie contract represent approximately 2/3 of budget.
 Maintenance free landscaping plan should reduce cost by about 1/3
- Discussed goal to keep lowering homeowners assessment
- Discussed when we want to hold budget meeting

- Discussed making sure we include 5 year pond maintenance costs in budget each year
- Discussed if reserves are available for ancillary projects
