Meeting called to order at: 7:52

- 1) Meeting brought to order Steve Berner (President)
- 2) Proof of notice of meeting
- 3) Read Minutes from last annual meeting (03/20/12)
 - Motion to approve minutes
 - MSP 6-0
- 4) Presidents report (Steve)
 - Assessment had been lower every year since high point
 - HOA responsible for repairing damage to HOA owned property
 - Continue to improve neighborhood and reduce assessments
 - Fewer compliancy issues
 - Currently two residence behind on dues
 - i) Working to rectify situations
- 5) ACC Report (Rich)
 - HOA landscaping changes
 - i) Move toward low maintenance landscape

- No major changes by individual homeowners
 - i) One new shed this year
- One residence has remaining compliance issue but showing some improvement
- Discussed pet issues
 - i) Pet limits with inside animals
 - ii) No livestock or commercial breeding allowed
 - iii) Discussed if a specific resident has a compliance issue
 - iv) Question from floor regarding new dog is neighborhood
 - (1) New dog is in training to become a service animal
 - v) Rich to inquire about dog situations
 - (1) Neighbors with dog complaints must report to county animal control
 - (2) Discussed role of animal control and its effectiveness
 - vi) Discussed livestock rules in bylaws and CCR's
- Discussed if people reporting to Sheriff violations of people parking in walkway
 - i) No parking is allowed in walkways Sheriff can issue parking ticket to violators
 - ii) Low priority to Sheriff's department however
- 6) Financials Report (Becky)
 - Reviewed 2012 & 2013 budget
 - Discussed opening savings account for cash reserves such as pond maintenance
 - Question from floor: is end goal to get assessment as low as possible?
 - i) Hope to get into \$300-\$400 range eventually
 - ii) New low maintenance landscaping part of plan to lower dues
 - (1) Hope to only need a landscaper 3 times a year

- Discussed website and if some links are broken
 - i) If some older items should be removed from website
- 8) Question from floor regarding dog in invisible fence area
 - What to do if there is a trespassing dog causing problems for resident dog
 - Animal control complaint and civil litigation are main options short of physical fence
